#### **Duration and Termination:**

This MOU shall be effective from the date of signing by both parties and will remain in effect for a period of three years.

Either party may terminate this MOU by providing a written notice of termination at least 90 days prior to the intended termination date.

#### Confidentiality:

The Parties agree to maintain the confidentiality of any proprietary or sensitive information shared during collaboration.

Any publications, research, or other scholarly work resulting from the collaboration shall appropriately acknowledge the contributions of both Parties.
