A Great Bhikshu In Education-Late Principal P.V. KANAL JI (Revered Baba Ji)



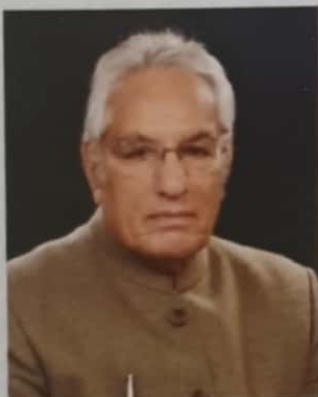

An Intellectual Giant - Late Principal DHARM BIR JI

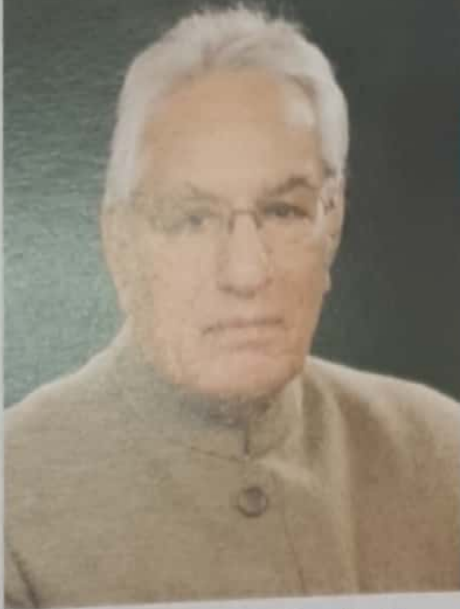

BRIEF HISTORY OF THE COLLEGE

Dev Samaj is a religious body which stands for very high principles. It is devoted to the highest service of humanity at large and even to the sub-human kingdoms. The chief work of Dev Samaj is the development of high character, life of trustworthiness, service and sacrifice in all relations. The most worshipful Founder of Dev Samaj, BHAGWAN DEV ATMA, was the first to emphasize the foremost need of higher character of individuals and its unique importance for the nation.

With the object of moral regeneration of the growing generation, Dev Samaj opened more than two dozen educational institutions.

The most worshipful BHAGWAN DEV ATMA was keenly alive to the importance of Women Education and realized that no country could prosper where women are not able to work side by side with men and discharge their peculiar duties properly.

For the purpose of realizing this, Dev Samaj Girls High School, Ferozepur was started in the year 1901 in the backward area of the rural district where women education was considered a taboo. It is a part of history that Dev Samaj Girls High School, Ferozepur played a laudable role in spreading women education in Punjab. To meet the increasing public demand, Dev Samaj Managing Council decided to start Dev Samaj College for Women at Ferozepur in 1934.

To fulfil the demand of quality teachers for schools, Dev Samaj Managing Council decided to start Dev Samaj Training College for women in 1942. Dev Samaj Training College for Women, Ferozepur City is the oldest Women Teachers Training College in the whole undivided State of Punjab.

Centre for Educational Technology and Computer laboratory

During the past few years, the college has acquired a large number of modern gadgets, equipments, audio-visual aids such as computers, projectors, epidiascope, overhead projectors, T.V., V.C.R., Photo copier etc. This lab provides administrative and academic technology and support to aid the college community in achieving the goals of providing and receiving the best education possible while using the tools of technology.

Hostel

The hostel facility in the campus makes it easy for the students to find a home away from their home. Admission

- ▶▶ Online Centralised admission to B.Ed for the Session 2015-17 will take place in the college as per notification of Punjab Govt.
- ▶▶ Centralized admission to M.Ed for the session 2015-17 will be conducted by Panjab University after written test.

Prospectus

Every student seeking admission to the college shall obtain a copy of the college Prospectus from the office on payment at the counter.

Application Form

Application for admission must be made on the prescribed form supplied free along with the prospectus.

Students Migrating from other Universities

Candidates from university other than Panjab University will have to submit the Migration Certificate in original and Original Detailed Marks Card of last exam passed with in 20 days from the date of enrolment. Failing which they will have to pay late fee to Panjab University, Chandigarh as per the rules and instructions of Panjab University.

Seats in the Hostel

A separate admission form shall have to be filled up for a seat in the Hostel and students will have to abide by all the rules and regulations of the hostel as given in the prospectus.

The security of the previous academic session will be refunded only from 1st Dec. to 31st Dec. of the current session, thereafter it will lapse.

The Registrar, Panjab University, Chandigarh has communicated in his letter dated

HOSTEL RULES

- 1) **It is Compulsory for all the students to live in the hostel whose Permanent residences are situated beyond 25 Km of the College Campus. Such students are not allowed to stay anywhere else except in our college hostel. Stringent Disciplinary action will be taken for the defaulters.**
- 2) The Principal/Members of Hostel Committee will inspect the hostel frequently
- 3) Allotment of the rooms is done by the Hostel Incharge in consultation with the Principal.
- 4) A boarder may be asked to leave the hostel if her hostel fees is more than a month in arrears.
- 5) A boarder may be expelled from the hostel if she stays away from the hostel without permission or is negligent in studies or is found guilty of misconduct.
- 6) If a boarder remains absent, being on leave from the college, shall have her seat reserved for her for a period not exceeding one month on payment of full fees for the period of absence.
- 7) Lights shall remain switched off from 11.00 p.m. to 5.00 a.m. For late night studies, special permission has to be obtained from the Principal/Hostel Incharge.
- 8) Lights and fans must be switched off when not in use. Students found keeping lights on in their absence from the room will be fined for their negligence.
- 9) The use of any kind of electrical appliances like heater, rod, iron or stove etc. is not allowed in the hostel. Disciplinary action will be taken against the defaulters.
- 10) All reports of thefts etc. (if any) should be made to the Hostel in-charge immediately. The residents are advised to keep their belongings locked up. They must not keep expensive Jewellery or cash exceeding Rs. 100/- with them.
- 11) All complaints against rowdy students would be made to the Hostel Incharge. No student is allowed to take law into her own hands.
- 12) Boarders shall not pluck flowers or leaves of plants. They should avoid sitting at all odd places. Walls, doors and furniture should not be defaced with pencil and ink marks or scrubbing.
- 13) Shouting, hooting, violent knocking or any other such act, movement or behaviour that is likely to cause disturbance is strictly prohibited. There shall be no loud discussion or chatting in the verandahs on any hour of the day or night. No student is allowed to whistle as whistling by girls is not lady-like.
- 14) Removal of electric holders, electric bulbs from the room is punishable with a heavy fine. Residents are not to tamper with the electric and sanitary installations. The cost of repairs or any damage done, will be realised from the students, in addition to a fine for negligence.
- 15) An order of the Principal or the Hostel In-charge conveyed through the peon shall be immediately obeyed.
- 16) All the boarders shall dine in the Mess Dining Hall. On no account shall a boarder order a servant to serve her meals in her own room.
- 17) No non-vegetarian food is cooked or allowed to be cooked or eaten in the college/boarding house.
- 18) Meals are served at fixed hours. Late comers will not be served any food.
- 19) A boarder, staying out of the hostel with the permission of the Principal/Hostel In-charge is not entitled to a refund of her mess charges except college vacation. Boarders will pay mess charges for any leave they avail of, except for vacations or holidays declared by the university or institution.

- 20) Boarders shall not take the hostel utensils to their rooms other than the utensils belonging to them.
- 21) Servants shall not be encouraged to enter the students' rooms. Nor shall they be asked by boarders to run private errands for them.
- 22) Students shall not have articles on credit from shops. Cash payment must be made for all purchases. This applies to purchases from the college stores and canteen also.
- 23) Washerman, Dry Cleaners and Tailors etc. not approved by the Principal, must not be engaged.
- 24) Students' Mess Committee is to meet at least once a month.
- 25) If mess charges are not paid by the 10th of every month meals may not be served.
- 26) Students are not allowed to enter the area beyond college stage towards Principal's Residence after college hours.
- 27) Furniture will be provided by the Hostel In-charge. The boarders should use and handle the furniture with care. The furniture should not be damaged or disfigured. The students should bear in mind that Hostel Building and Hostel furniture etc. are as much their property as that of the college.
- 28) No boarder shall leave the Hostel without personally handing over the charge of the furniture to Hostel In-charge. Each girl will be responsible for any breakage or damage to the furniture.
- 29) The resident students are expected to dress simply and modestly in keeping with the long standing traditions of the college. Wearing of heavy jewellery and use of cosmetics are also not permitted. They have to follow ideal of **'SIMPLE LIVING AND HIGH THINKING'**
- 30) Students are not allowed to enter the Dining Hall except properly dressed in suit with Dupatta.
- 31) Students are not allowed to talk, move about, write letters or read books other than of their subjects during fixed study hours.
- 32) The day-scholars are not allowed to visit the hostel except with written permission of the Teacher/Hostel In-charge, in a special case.
- 33) Any boarder who invites or allows the day scholars to visit them in the hostel will be fined heavily.
- 34) Cell-Phones are strictly prohibited. There is provision of P.C.O. in the college campus.

VISITORS

- 1) When a student joins the hostel, the Father/Guardian shall submit in the office personally or by post a list of visitors with their photographs who may be permitted to visit his ward in the Hostel and whom she may visit at their houses. Only three visitors including parents & local guardian are allowed
- 2) This list is to be submitted on prescribed form available in the office. Every column of this form shall be filled in neatly by the Father/Guardian.
- 3) A person whose name does not appear in the given list and whose specimen signature and photographs are not there shall not be allowed to visit the students unless he brings a letter of permission from the student's Father/Guardian.
- 4) The Principal can, at her discretion, disallow a person named in the list to visit a student.
- 5) No boarder is allowed to meet a visitor Male or Female without the permission of the Hostel

- Incharge. Severe action would be taken against a boarder disobeying this order.
- 6) Any other restriction which parents may desire to be imposed on their wards should be sent to the Principal by the Father/Guardian in writing alongwith the visitor's list.
 - 7) Specimen signature of all the visitors must be supplied, on the Visitors' list. Photographs of all visitors must also be supplied duly authenticated by the Father/Guardian.
 - 8) Such relatives of the boarders who themselves are students would not be allowed to act local guardian of the boarders.

RULES FOR LEAVE FROM THE HOSTEL

1. No student can leave hostel without the prior permission of the Hostel Incharge/Principal.
2. The resident scholars would be allowed to visit only such relatives as have been approved by the Principal.
3. Leave from the hostel to stay out with approved local or out-station relatives would not be granted more than twice a month including vacation.
4. Leave or absence from the college does not mean leave from the hostel. Leave from hostel must be obtained personally on prescribed Leave form from the Hostel Incharge at least two days before it is availed of. Leave Application must be supported by a letter of permission from Father/Guardian. Father/Guardian should send letter of permission by post so as to reach the Hostel Incharge two days before the leave is required. A duplicate copy of the letter of permission be sent to his ward to be attached by her with leave application.
5. Leave from the close days should be obtained on prescribed Leave Form from the Hostel Incharge at least two days before availing of it. If leave is required on a working day, it should be obtained from the Principal after obtaining Hostel Incharge's recommendation.
6. Hostel Incharge/Principal be approached for leave during hours fixed for this purpose.
7. No boarder shall be allowed to leave the hostel alone to visit her local relatives. The local guardians must send some one to escort her out and to leave her back to the hostel.
8. No boarder shall be allowed to leave station to visit her parents/guardians unless a permission letter has been received by post by the Principal/Hostel Incharge from parents/guardians.
9. The parents/guardians should inform the Hostel Incharge in writing about the arrangements made by them for escorting their wards during the holidays.
10. Boarders who absent themselves from the hostel without previous permission from the Hostel Incharge would be do so at their own risk. Penalty may take the form of expulsion from the hostel.
11. A boarder before leaving the hostel for short or long period, shall enter her departure time in the Exit Register. On return to the hostel, she shall make entry of time of her return in the Entrance Register.
12. A boarder on leave from the Hostel, must be back in the hostel by 5.00 p.m. in winter and by 6.00 p.m. in summer on the day her leave expires.
13. After a long vacation all resident students are required to be back in the hostel in the evening before college re-opens. No leave for joining late will be granted except on medical grounds supported by a certificate from a qualified Medical Practitioner. The defaulters shall be punished and their privilege may be forfeited.
14. The boarders shall maintain their Record Book properly.

WITHDRAWAL FROM HOSTEL

1. Application for withdrawal from the hostel should be submitted to Principal through the Hostel Incharge on the prescribed form duly endorsed by the father/guardian. Until a boarder has withdrawn her stay formally she shall have to pay hostel fee and fine if any, even though she has vacated her room. No boarder shall leave the hostel without clearing all hostel dues and personally handing over the charge of the hostel articles issued to her.
2. After the University Examination, no student will be allowed to stay in the college Hostel during the Summer Vacation.

MEETING AND PARTIES

For all meetings and parties to be held in the hostel, permission of the Principal must be obtained in advance. List of non-resident invitees to the hostel parties and functions should be submitted to the Principal through the Hostel Incharge, for approval, before issuing the invitation.

MISCELLANEOUS

1. No Society or Association can be formed in the hostel unless approval by the Principal with regard to its constitution has been obtained beforehand.
2. Notice put up the Notice Boards which do not bear the sign of the Principal or of the Hostel Incharge have no validity. Students are not permitted to put up such Notice.
3. Students are advised not to give any gift, in any form, to any employee of the college Hostel/Mess/Canteen without written permission of the Principal.
4. Any problem/complaint regarding Hostel/Mess/P.C.O./Canteen should be brought to the notice of the Principal.
5. Banking Facilities are also available. A branch of the State Bank of India is functioning in the College Campus. Parents can remit money to their wards by Cheques/Drafts payable at any bank at Ferozepur.

NOTE

All rules in the hand-book should be carefully read and scrupulously observed. Any breach thereof will render the student liable of heavy punishment in the form of fine, withdrawal of concession and stipend or even expulsion from the Hostel depending on the seriousness of the offence. It is no pleasure for the authorities to punish the student and if they have to resort to it sometimes, it is only in the interest of discipline of the Institution. The authorities, however, earnestly hope that the student should so conduct themselves are not to give them any occasion to resort to some unpleasant duty. Ignorance of rules will not be accepted as an excuse for this non-observance.

Hostel Rules, College/Hostel dues are subject to the change and such changes shall be binding on all students.

All charges (if any) in the above rules and regulations will be duly notified.
